WELFARE RIGHTS

ENERGY COSTS

At WIBSS we appreciate that the current cost of living crisis may be having an impact on our beneficiaries. We recognise that due to ongoing health conditions, the impact may affect some more than others.

We have, therefore, compiled some information around current energy grants and water savings, which may be available to you.

IF YOU OWN YOUR HOME OR RENT FROM A PRIVATE LANDLORD (NOT COUNCIL OR HOUSING ASSOCIATION)

Is your home hard to heat? You could be eligible for home energy efficiency improvements at no cost to you.

The Nest scheme is part of Welsh Government Warm Homes. Nest install free boilers, central heating systems and insulation to help households on low incomes to keep warm and reduce the cost of their energy bills, alongside tailored energy advice.

You could be eligible for free energy efficiency improvements if:

• You own your home or rent from a private landlord (not Council or Housing Association)

- Your home is energy inefficient and expensive to heat
- You or someone you live with receives a means tested benefit **OR** has a chronic respiratory, circulatory, or mental health condition **and** an income below defined thresholds.

If you are eligible, Nest will recommend a package of energy efficiency improvements at no cost to you. These improvements will make your home warmer and save you money on your energy bills.

Nest advisors will ask you some questions about your property and the benefits you receive, so please make sure you have your benefit award letter and, if applicable, your landlord details to hand when you make the call.

If you wish to apply, and want help completing the application, or if you have any questions first - as a WIBSS beneficiary, you have access to your own dedicated welfare rights service. We can clarify what health conditions and income thresholds are eligible, if you do not receive a means tested benefit.

WATER RATES - WELSH WATER

WATERSURE WALES

If you are on certain benefits, have a water meter (or opt in to have one) and use a lot of water because you either have a medical condition or three or more children aged under 19 for whom you claim Child Benefit, you may be able to get help from the WaterSure scheme.

Crucially the eligible benefits are not all means tested. So, if you receive Attendance Allowance (AA), Disability Living Allowance (DLA) or Personal Independence Payment (PIP) you can also apply, providing you (or someone in your household) has a medical condition that requires additional water.

Common examples include;

- Desquamation (flaky skin disease)
- Weeping Skin (eczema, psoriasis, varicose ulceration)
- Incontinence
- Abdominal Stoma
- Crohn's Disease
- Renal failure requiring home dialysis (except where the health authority contributes to the cost of the dialysis

• If your condition is not listed here, but still requires a significant amount of water, you may provide information in your application.

WaterSure caps your annual metered bill amount, so you won't pay over a certain amount for the year, no matter what your actual consumption is.

The Bill Cap - WaterSure Wales charge from 1 April 2023 to 31 March 2024 is £403.31 (£166.32 for water, £236.99 for sewerage).

WELSH WATER HELPU TARIFF

The HelpU tariff helps low-income households by putting a cap on the amount you have to pay for your water. The annual HelpU charge is £291.30 (£124.01 for water, £167.29 for sewerage, you will need a water meter (or opt in to have one), someone in the household must receive at least one means-tested benefit and the combined annual household income must be on or under the threshold.
